Blood alcohol level

Undersigned agrees that if in the opinion of the Company the Undersigned appears impaired due to alcohol, the Company may request a breathalyzer blood alcohol test to determine if the Undersigned is legally drunk. The Undersigned has the right to refuse at which time his/her right to continue on with the activity will be revoked with no refund. If the Undersigned agrees to the test and the BAC is .08 or greater, the Company will revoke the Undersigned's right to continue on with the activity. The Undersigned acknowledges that the breathalyzer used for the test is not a Law Enforcement grade instrument and is subject to inaccuracies and agrees to accept reading. The Undersigned acknowledges that it is not the Company's responsibility to determine whether he/she is impaired and unsafe for the activity.

Unsafe Behavior

Undersigned agrees and acknowledges that if in the opinion of the Company he/she is acting in an unsafe manner, the Company may revoke their right to shoot with no refund.

Photo Release

The Undersigned acknowledges that the company is taking photos and videos during the event and may use them for promotional purposes. If you do not consent to the use of these photos or videos please inform the staff prior to the shooting.

In consideration of being permitted to attend this event shooting guns, for the experience in shooting various guns, (herein referred as "the Activity"), for use of premises, and for other good and valuable consideration the Undersigned agrees to and acknowledges the following :

Undersigned agrees to indemnify, hold harmless and defend Beyond Vegas LLC, dba Gunblast Vegas, (herein referred as the Company), the facility (herein referred as "The Premises") in which the activity is being held, the Company's agents, booking agents, brokers, and subcontractors from any and all fault, liabilities, costs, expenses, claims, demands or lawsuits arising out of, related to or connected with : Undersigned presence at and/or participation in the Activity, the discharge of guns by Undersigned, Undersigned's presence on or use of the range, buildings, land and premises, and any and all acts or omissions of Undersigned.

Undersigned furthermore waives for himself/herself and for his/her executors, personal representative, administrators, assignees, heirs and next of kin, any and all rights and claims for damages, losses, demands and any other actions or claims whatsoever, which he/she may have or which may arise against any staff member (including but not limited to the death of Undersigned and/or any and all injuries, damages or illnesses suffered by Undersigned or Undersigned's property) which may, in any way whatsoever, arise out of, be related to or be connected with the Activity, the Premises, including any latent defect in the Premises; Undersigned's presence on or use of said Premises; Undersigned's property (whether or not entrusted to staff member)/ and the discharge of guns. Staff members shall not be liable for, and Undersigned, on behalf of himself/herself and on behalf of his/her executors, personal representatives, administrators, assignees, heirs and next of kin, hereby expressly releases the staff members from any and all such claims and liabilities.

Undersigned hereby expressly assumes the risk of taking part in the Activity shooting various guns and taking part in the Activity on the Premises, which include, but are not limited to, the use of guns, the discharge of guns and firing of live ammunition, the use of explosives.

Undersigned expressly agrees that this instrument is intended to be as broad and inclusive as permitted by law, and that if any provision of this instrument is held invalid or otherwise unenforceable, the enforceability of the remaining provisions shall not be impaired thereby. No remedy conferred by any of the specific provisions of this instrument is intended to be exclusive of any other remedy, and each and every remedy shall be cumulative and shall be in addition to every other remedy now or hereafter existing at law or in equity or by statute or otherwise. The election of any one or more remedy hereunder by the Company shall not constitute any waiver of Company's right to pursue other available remedies. This instrument binds Undersigned and his/her executors, personal representatives, administrators, assignees, heirs and next of kin.

You acknowledge that there are no refunds or credits towards future shoots if you do not complete your package.
